Principal Office

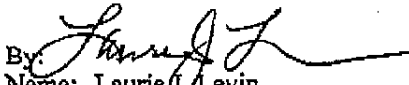

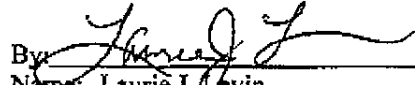
