**ARTICLES OF ORGANIZATION
OF
THE PERFECT 10 STRENGTH TRAINING, LLC**

ARTICLE I

NAME AND ADDRESS

The name of this Limited Liability Company shall be **The Perfect 10 Strength Training, LLC**. The mailing address and street address of the principal office of the Company is 4980 Cerromar Drive, Naples, FL 34112.

ARTICLE II

DURATION

The Company shall exist perpetually until dissolved pursuant to a written agreement of all members of the Company, or as provided by law, or as provided by the Company's Operating Agreement.

ARTICLE III

DESIGNATION OF REGISTERED AGENT

ARTICLE IV

ARTICLE V

MANAGEMENT OF COMPANY BUSINESS

The Company's day to day business will be managed by one or more of its members and is therefore a member-managed company.

ARTICLE VI

ADDITIONAL MEMBERS

The Members may admit additional members upon Certificate of Membership signed by the existing Managing Members.

ARTICLE VII

LIMITATIONS ON MEMBERS

The Members shall not take any action on behalf of this Company that is prohibited by the Florida Limited Liability Company Act, or any action that requires consent of the other Members of the Company without first obtaining the prior written consent of all Members of the Company. Pursuant to Section 608.424 of the Florida Limited Liability Company Act, no Member of the Company shall be an agent of the Company solely by virtue of being a member, and no Member shall have authority to incur debt or contractual liability on behalf of the Company solely by virtue of being a member.

ARTICLE VIII

RIGHT TO CONTINUE BUSINESS OF COMPANY

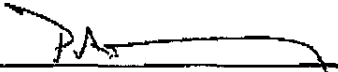

AMENDMENTS

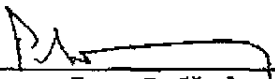
These Articles may be amended from time to time by the written consent of the Managing Members of the Company.
