The name of the limited liability company (hereinafter referred to as the "Company") is "Ladybug Scrapbooking, LLC".

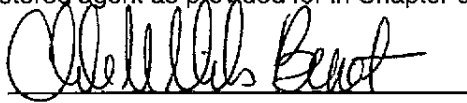
**ARTICLE II — Address:**

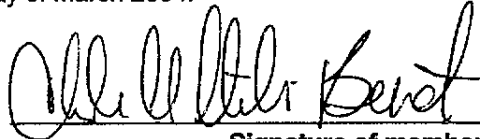
**ARTICLE IV — Limitation on Agency Authority of Members:**
