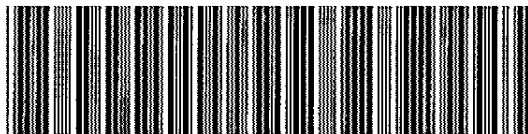

3. There is added an additional Article V to provide as follows:

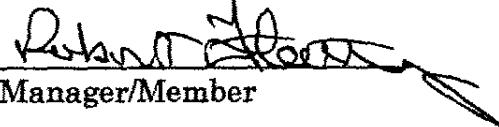
**Article V**
