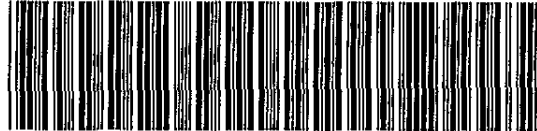

The name of the Limited Liability Company is SOUTHERN SHINE MOBILE DETAILING, L.L.C., hereafter called "Southern Shine Detailing".


