

**ARTICLES OF ORGANIZATION
OF
AMAZON RESTAURANTS, LLC**

Pursuant to the Florida Limited Liability Company Act, the undersigned, acting as organizer of a limited liability company, hereby adopts the following Articles of Organization for such company:

**ARTICLE I
NAME AND PRINCIPAL ADDRESS OF THE COMPANY**

The name of this limited liability company is: AMAZON RESTAURANTS, LLC. The principal place of business and mailing address of the limited liability company is: 13641 Tetherline Trail, Orlando, FL 32837.

**ARTICLE II
COMPANY EXISTENCE**

This limited liability company is to exist perpetually. The Company's existence shall be effective upon the filing of these Articles of Organization with the Florida Department of State.

**ARTICLE III
UNITS OF EQUITY OWNERSHIP**

Section A. Authorized Units of Equity Ownership. The maximum numbers of unity ownership units that AMAZON RESTAURANTS, LLC is authorized to have outstanding at one time is two hundred (200) units, all of which shall be identical units.

Section B. Restriction on Disposition of Units. No Member of this Company shall sell, transfer, convey, pledge, give, distribute or encumber any unit or units in the Company without first giving notice in writing to the Company of such intended disposition and without first securing the written approval of Members of the Company owning 100% of the then issued and outstanding Membership Units of the Company. However, nothing contained herein shall prevent distribution by operation of law of such unit or units, provided that in such case a transferee shall be bound by the provisions contained in this Section in the same manner as an original Member.
