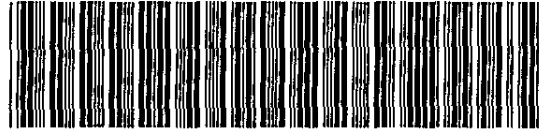

**ARTICLE 1
NAME**



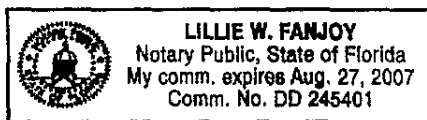
