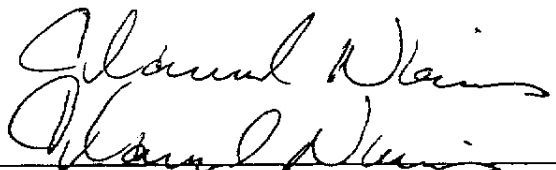
**ARTICLE VIII – Admission of Additional Members:**

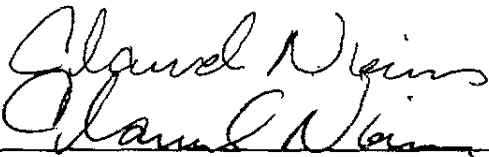
