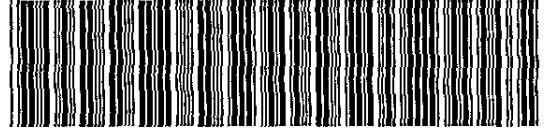

ARTICLE I - Name

The name of this limited liability company shall be J. R. BAUER CONSTRUCTION, LLC.

ARTICLE II - Duration

The limited liability company shall have a perpetual existence.

ARTICLE III - Purpose and Powers

Except as restricted by these Articles of Organization, this limited liability company is organized for operating a business of constructing building improvements for the general public as well as each and every legal and lawful purpose for which a limited liability company may be organized pursuant to the Florida Limited Liability Company Act.

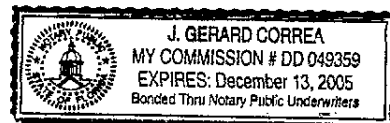
