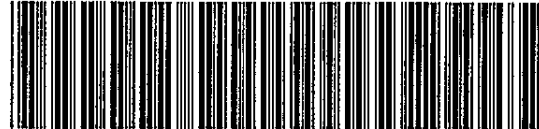

ARTICLE I - NAME

The name of the Limited Liability Company (hereinafter referred to as "Company") is WECOLA, L.L.C.

ARTICLE VIII - EVENTS OF DISSOLUTION

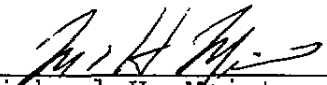
The Company shall be dissolved upon the happening of any of the following:

1. Upon written agreement of two-thirds of the Membership.

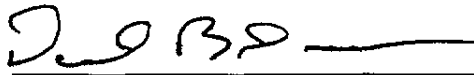
