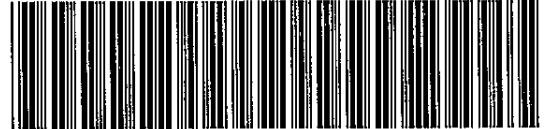

The name and street address of the initial registered agent are Kenyon S. Atlee, 4501 Beverly Avenue, Jacksonville, Florida 32210.


ARTICLE IV - MANAGERS
