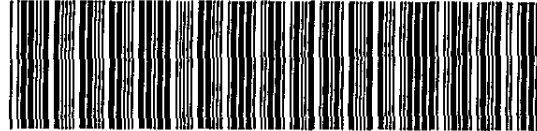



The Company is to be managed by its sole member and managing member WILBERTO RIVERA.


ARTICLE V — Limitation on Agency Authority of Member:
