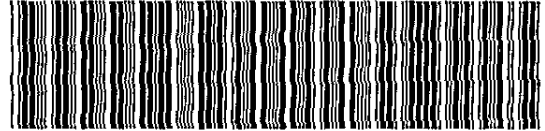

**ARTICLES OF ORGANIZATION
OF
ON TIME PROCESS SERVICE, LLC**

The undersigned subscriber to these Articles of Organization is a natural person competent to contract and hereby forms a limited liability company under the laws of the State of Florida.

ARTICLE 1 - NAME

The name of this limited liability company is On Time Process Service, LLC, (hereinafter, the "Company").

ARTICLE 2 - PRINCIPAL OFFICE

The initial mailing and street address of the principal office of this Company is 10 Pine Course Way, Ocala, Florida, 34472. The Company may from time to time move the principal office to any other location.

ARTICLE 3 - REGISTERED OFFICE AND REGISTERED AGENT

The initial address of the registered office of this Company shall be the same as the principal office of the Company. The initial registered agent shall be Charles J. Champion, Jr.

ARTICLE 4 - EFFECTIVE DATE

These Articles of Organization shall be effective on March 22, 2004.

ARTICLE 5 - OPERATING AGREEMENT


The Company may adopt one or more Operating Agreements which will govern the affairs of the Company. The first Operating Agreement may be adopted by a majority in interest of the members. Amendments to the Operating Agreement or subsequent Operating Agreements may be adopted by the same method unless otherwise provided for in an Operating Agreement then in effect.

ARTICLE 6 - MANAGEMENT

The Company shall be a member managed Company unless otherwise specified in the Operating Agreement. However, no member shall have any authority to act as an agent for the Company, bind the Company, or incur any liability on behalf of the Company except as specifically provided in the Operating Agreement or by resolution adopted by a majority-in-interest of the members.

ARTICLE 7 - AMENDMENT

These Articles of Organization may be amended by a majority in interest of the members or as otherwise provided for in an Operating Agreement then in effect.

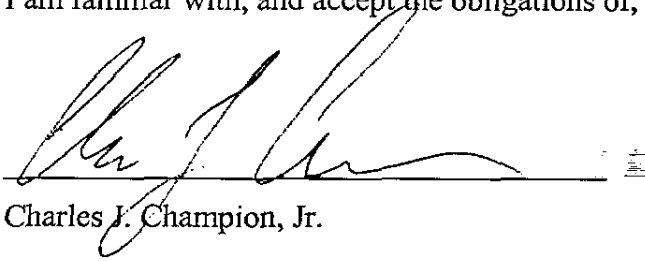
