



## ARTICLES OF ORGANIZATION

of FIRST OPPORTUNITY, LLC , A Florida Limited Liability Company

1. Name: The name of the limited liability company is FIRST OPPORTUNITY, LLC (sometimes hereinafter referred to as the "LLC").

2. Purpose: The purpose of this limited liability company may include the transaction of any and all lawful business for which limited liability companies may be organized in the state of Florida.

3. Address of Principal Office: The address of the registered office of the limited liability company is 775 E. Merritt Island Causeway, Suite 320, Merritt Island, FL 32952; mailing address: 1515 Huntington Lane, #214, Rockledge, Florida 32955. The registered agent at that address is Jerry L. Jester, 775 E. Merritt Island Causeway, Suite 320, Merritt Island, Florida 32952.

4. Members at Time of Formation: The initial members are Richard T. Moore, Jr., Richard T. Moore, III and Mary Elizabeth Moore.

5. Period of Duration: The period of duration of this LLC shall be perpetual.

6. Management: Management of the LLC at the time of formation is reserved for the initial member whose name and address are as follows: Richard T. Moore, III, 1515 Huntington Lane, #214 , Rockledge, Florida, 32955.

7. Admission of New Members: With the written unanimous consent of the existing members, new members may be admitted into the LLC from time to time upon the payment of such capital contributions and upon such terms as the then existing members unanimously decide. 

10. Profits and Losses: Members shall share profits and losses of the LLC in the same percentages as their capital contributions bear to the total of contributed capital, or as may be set forth in the Operating Agreement signed by the members.

11. Regulations (Operating Agreement): Any Regulations (as defined in Section § 608.402 (24) of the Act), relating to this Limited Liability Company must be in writing and signed by all of the Members.
