NAME

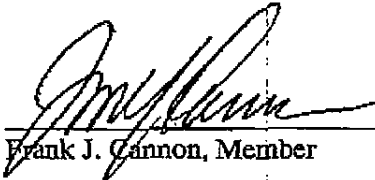
ARTICLE IX**AMENDMENT**

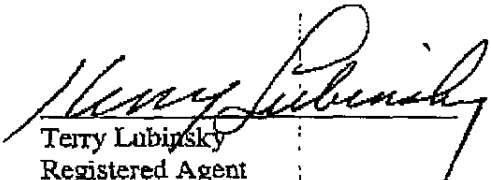
