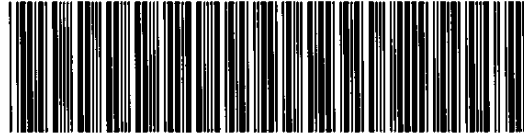

- II. The Articles of Organization are hereby amended as follows:

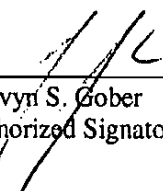
Article I of the Articles of Organization is deleted in its entirety and replaced with the following:
