**ARTICLES OF ORGANIZATION

ARTICLE I

The Company shall be managed by its member(s), Walbridge Aldinger Company, 410 Ware Boulevard, Tampa, Florida 33619.

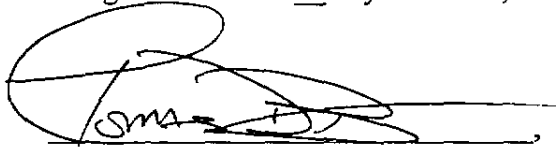
ARTICLE VI
