## ARTICLES OF ORGANIZATION OF BEACH AVENUE, L.L.C.

The undersigned authorized representative, for the purpose of forming a lipsited legility company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

#### **ARTICLE I -- NAME**

The name of the limited liability company shall be **BEACH AVENUE**, ("Company").
