ARTICLES OF ORGANIZATION OF

ARTICLE I

NAME AND PRINCIPAL PLACE OF BUSINESS

The name of this limited liability company shall be L. INVESTMENT, LLC, and the mailing address and street address of its principal office shall be 12730 S.W. ARTICLE II
