ARTICLES OF ORGANIZATION

OF

OF SHEET The undersigned, for the purpose of forming a limited liability company un the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereigh makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be THE CITY GUIDES COMPANY LLC, ("Company").
