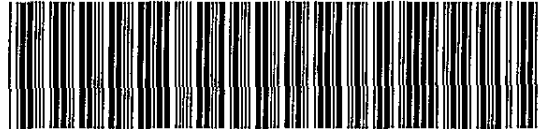




ARTICLE VI – AMENDMENTS
