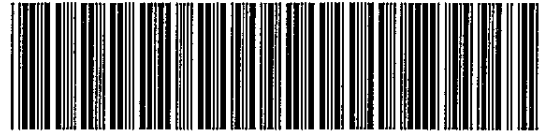

Management

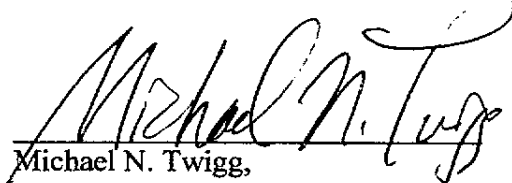
The Company shall be managed by its members.
