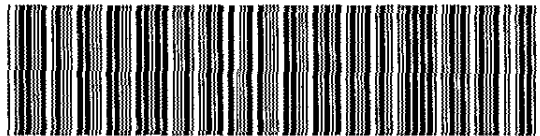

#### ARTICLE IV: MANAGEMENT OF THE COMPANY


