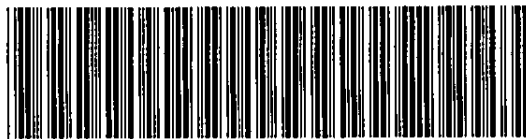


At a meeting of Paradigm NYC Office LLC held December 26, 2012, for which notice was waived and at which all members were present, the following action was approved unanimously:
