#### ARTICLES OF ORGANIZATION

#### **FOR**

#### BAY POINT TITLE, L.L.C.

#### A Florida Limited Liability Company 5700 Crooks Road, #107 Troy, Michigan 48098

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

#### ARTICLE I NAME

The name of this Limited Liability Company shall be BAY POINT TITLE, L.L.C. (hereinafter "L.L.C.").

# ARTICLE II ADDRESS

# ARTICLE V ADMISSION OF NEW MEMBERS

Except as set forth in the regulations, no additional members shall be admitted to the L.L.C. except with the unanimous written consent of all the managers of the L.L.C.

#### ARTICLE VI MANAGEMENT

The L.L.C. shall be managed by a members and is, therefore, a member-managed company.

# ARTICLE VII INDEMNIFICATION

In addition to any rights and duties under applicable law, the L.L.C. shall indemnify and hold harmless all of its present and former members from and against all liabilities and obligations, including attorneys' fees, incurred in connection with any actions taken or failed to be taken by said manager in their capacity as such except for willful misconduct or gross negligence.

The headings or captions of these various Articles are inserted for convenience and none of them shall have any force or effect, and the interpretation of the various Articles shall not be influenced by any of said headings or captions.
