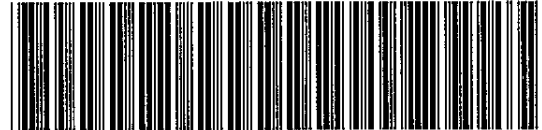

The name of the Limited Liability Company is to be JWTA, LLC.


ARTICLE II BUSINESS PURPOSE

ARTICLE XII TRANSFERS


Terms and conditions restricting transfer of member interests are provided in the operating agreement.

ARTICLE XIII DURATION


The Company will continue to exist until the date specified in the operating agreement.
