ARTICLES OF ORGANIZATION
FOR
631 Atrium, LLC, a Florida Limited Liability Company

The undersigned, desiring to form a limited liability company under and pursuant to Florida Statute 608 entitled the Florida Limited Liability Company Act, does hereby adopt the following Articles of Organization for such company:

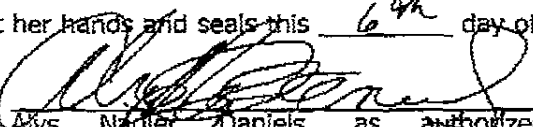
1. Name. The name of the limited liability company is: 631 Atrium, LLC

4. Admission of Additional Members; and Terms and Conditions of such Admissions. Additional Members may be admitted only upon the unanimous approval of the nontransferring members of the Company upon the written application of such new Member, in the manner set forth in the Operating Agreement of the Company.
5. Management of Company. The business of the Company is to be managed by one or more members and is therefore, a member-managed company. The name and address of the initial Managing Member is:

6. Purpose. Notwithstanding any other provisions of these Articles and so long as any obligations secured by a first priority mortgage, deed of trust or deed to secure debt incurred in connection with any financing of the Property (a "Security Instrument") remain outstanding and not discharged in full, this provision may not be amended without the consent of all members and the holder of said Security Instrument.

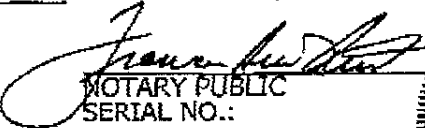

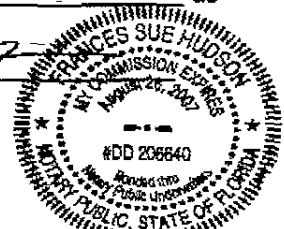
