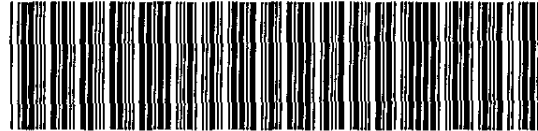

The name of the Limited Liability Company is: CHEWEY PROPERTIES, LLC

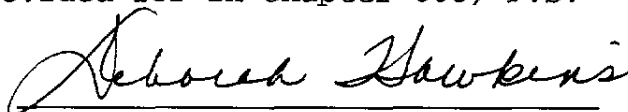

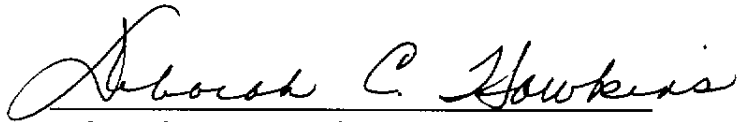
