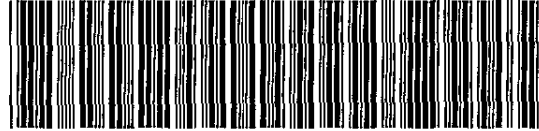

**ARTICLES OF ORGANIZATION  
OF  
DAY BREAK RIDGE FARMS, LLC**

1. Name. The name of this limited liability company is **DAY BREAK RIDGE FARMS, LLC** (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.

2. Duration. The Company shall exist from the date of filing of these Articles of Organization with the Florida Secretary of State, and the Company's existence shall be perpetual.

3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.

4. Place of Principal Office. The mailing and street address of the Company's principal office is 3502 Henderson Boulevard, Suite 300, Tampa, Florida 33609.



7. Management of the Company. The management of the Company shall be vested in the managers of the Company. The initial managers of the Company are Brandie L. Puls and John L. Puls, Jr.

8. Operating Agreement. The members shall have the power to adopt, alter, amend, or repeal the Operating Agreement of the Company containing provisions for the regulation and management of the affairs of the Company.
