
1. Name of Company. The name of the Company is DAY BREAK RIDGE FARMS, LLC.

2. Date of Filing of Articles of Organization. The Company filed its Articles of Organization (the "Articles") with the Florida Department of State on April 8, 2004, a copy of which is attached hereto and made a part hereof.

3. Correction to Articles of Organization. Paragraph 1 of the Company's Articles incorrectly reflects the name selected by the member and managers of the Company and is hereby corrected to read as follows:
