

Article V (Purpose)

The purpose of SummunZ.com *LLC* is to contribute to the advancement of trade transparency between the United States and the Caribbean, through the provision of a internet portal that allows West Indians to access products or services, updated product or service information and have those products shipped from the United States to the Caribbean. The website will provide all necessary tools and resources to research, process and transport products on a timely basis, while ensuring customers the quality and authenticity of the products they are purchasing.

Article VI (Offices)

SummunZ.com Ltd. Co. shall have its principal or head office in the City of Lantana and its branch offices at other places as appropriate.

Article VII (Activities)

SummunZ.com Ltd. Co. shall perform the following activities for the achievement of the purpose as set forth in Article V.

1. Development, publication and dissemination of product, shipping and packaging standards;
2. Collection assessment, studies and research, translation and publication latest shipping advances and standards as well as information on standardization trends, etc;
3. Research and development of shipping practices for standards development as well as dissemination thereof;
4. Organizing and coordinating the activities of national Study Groups, etc. participating in the standardization work organizations;
5. Hosting of international conferences, meetings, seminars and presentations, etc. on shipping and transshipment technology and standards;
6. International cooperation with United States and Caribbean Customs agencies and organizations.
7. Adhering to all World Customs regulations and maintaining an atmosphere of cooperation, inclusive of full disclosure of shipping practices to all government agencies;
8. Cooperation with United States, Caribbean and all relevant Governments, national and international agencies and organizations, performing such tasks or services as entrusted to SummunZ.com Ltd. Co. by them or entrusting certain tasks or services to them;
9. Such projects or tasks as entrusted to SummunZ.com Ltd. Co. by the United States Government in accordance with the provision of laws and administrative orders.
10. Other activities necessary for the achievement of the purpose of SummunZ.com Ltd. Co. and activities contingent to the performance of the activities listed above.

Article VIII (Classification of Assets)

The assets of SummunZ.com Ltd. Co. shall be classified into basic assets and operating assets.

Article IX (Basic Assets)

1 SummunZ.com Ltd. Co. classifies the following assets into the basic assets class:

1. A capital investment of 1000 US Dollars which was fixed by the founding committee as the basic assets at the time of incorporation.
2. The portion of the financial assets of SummunZ.com Ltd. Co. acquired through donations, contributions and/or subsidies from the Government and business firms, which was classified into the basic assets category by the resolution of the Board of Directors of SummunZ.com Ltd. Co.
3. The portion of the operating assets or the surplus thereof transferred to the basic assets category by the resolution of the Board of Directors of SummunZ.com Ltd. Co.

Article X (Operating Assets)

SummunZ.com Ltd. Co. shall classify all the assets of SummunZ.com Ltd. Co. other than basic assets into the operating assets category.

Article XI (Restrictions on the Disposition of Basic Assets)

When intending to sell, donate, lend, lease, exchange, divert to other uses or offer as a mortgage any portion of its basic assets, SummunZ.com Ltd. Co. shall obtain prior permission through the approval by the resolution of the Board of Directors of SummunZ.com Ltd. Co.

Article XII (Operation Expenses)

1. Operating expenses of SummunZ.com Ltd. Co. shall be defrayed from its income from financial assets (interest, etc.), income from profit-making business, operating assets, membership fees paid by members and miscellaneous income, etc.
2. When it is difficult to defray all the operating expenses from the income and operating assets mentioned in Paragraph above, some of the operating expenses from the income and operating assets mentioned in Paragraph above, some of the operating expenses may be defrayed from the basic assets of SummunZ.com Ltd. Co. upon resolution of the Board of Directors.

Article XIII (Management of Assets)

The Board of Director shall determine how the financial assets of Association should be managed.

Article XIV (Principles of Accounting)

1. Accounting of business transactions of SummunZ.com Ltd. Co. shall be performed according to the principles of business accounting.
2. Financial statements of SummunZ.com Ltd. Co. shall be established according to the Rules of Financial Statements.

Article XV (Fiscal Year)

The fiscal year of SummunZ.com Ltd. Co. shall coincide with that of the United States Government.

Article XVI (Entry into Force)

These Articles of Association shall enter into force on April 16, 2004.
