These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter (608).

1. **Name:** The name of the limited liability company is Society Signature Coffees USA, LLC. ("Company").

2. **Mailing and Street Addresses:** The Company's principal mailing and street address is 15105 N.W. 77th Avenue, Suite #303, Miami Lakes, Florida 33014.

3. **Duration:** The Company shall exist from the date of filing these Articles with the Florida Department of State until the occurrence of any of the events specified in the Florida Statutes Section 608.441, unless continued by the unanimous consent of all of the remaining members.

4. **Management:** The management of the Company may be handled by either members or non-members. The following person will initially be the managing member:

5. **Additional Members:** Additional members to the Company may be admitted, but only if all the current members agree to the admission of the additional members and to the terms of admission.

6. **Members Rights to Continue Business:** If a member of the Company dies, retires, resigns, is expelled, is dissolved, experiences bankruptcy, or upon the occurrence of any other

event which terminates the continued membership of a member in the Company, the remaining members may, by unanimous written agreement, continue the business of the Company.

7. **Registered Agent and Office:** The name of the initial registered agent of the Company is Alan E. Greenfield, Esq. The street address of the initial registered agent of the company is 15105 NW 77 Avenue, Suite #303, Miami Lakes, Florida 33014.

8. **Regulations:** The members, by majority action, shall have the power to adopt, alter, amend or repeal regulations of the Company containing provisions for the regulation and management of the affairs of the Company.

9. **Date of Existence of the Company:** The existence of the Company shall commence on the date of the filing the Articles of Organization by the Florida Department of State.
