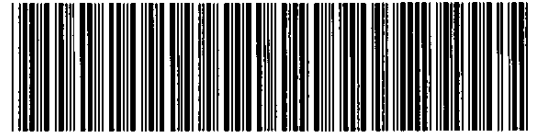

ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF

LWR COMMUNITIES, LLC, a Florida Limited Liability Company

Pursuant to the provisions of the Florida Statutes, the undersigned limited liability company adopts the following Articles of Amendment to Articles of Organization:

1. The name of the limited liability company ("Company") is LWR Communities, LLC.

2. The Articles of Organization of this limited liability company were duly filed with the Florida Department of State on April 9, 2004 and assigned Document Number L04000026993. Said Articles were superseded by the Amended and Restated Articles of Organization dated March 22, 2010, filed under document number L04000026993. Said Articles were amended by Articles of Amendment dated October 18, 2011. Said Articles were amended by Articles of Amendment dated October 26, 2011. The Member wishes to amend the Articles further by the adoption of this Articles of Amendment.

3. This limited liability company's Articles of Organization are hereby amended as follows:

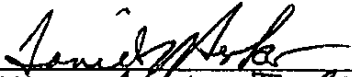

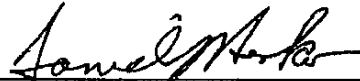
