**ARTICLES OF ORGANIZATION
FOR
MULTINATIONAL SYSTEMS MANAGEMENT, LLC**

ARTICLE 1 – Name. The name of the limited liability company shall be MULTINATIONAL SYSTEMS MANAGEMENT, LLC.
