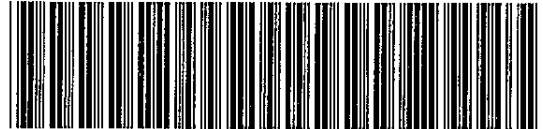

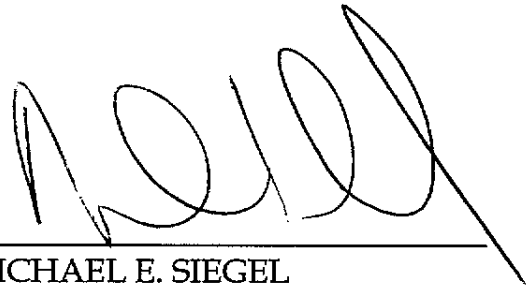
ARTICLE IV - DURATION
