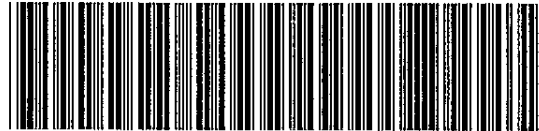

ARTICLE I

NAME

The name of this limited liability company is SUNCOAST INDEPENDENT, LLC., referred to in these Articles of Organization as the "Company."

ARTICLE II
