ARTICLES OF ORGANIZATION

OF

Englewood Dental Associates, P.L.

The undersigned person, acting hereby as Organizer for the purpose of forming a professional limited liability company under the Florida Statutes, Chapter 608 and Chapter 621, hereby executes the following Articles of Organization.

- I NAME. The name of the professional limited liability company shall be: Englewood Dental Associates, P.L. ("Company").
- II ADDRESS. The mailing address and street address of the principal office of the Company shall be 9718 S.W. 44th Terrace, Gainesville, Florida 32608.
- III DURATION. The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall be perpetual, unless the Company is dissolved as provided in these Articles of Organization.
- IV REGISTERED OFFICE AND AGENT. The name of the registered agent of the Company in the State of Florida is <u>Kevin I. Downey</u> and the street address of the registered office of the Company is 2631-B N.W. 41st Street, Gainesville, Florida 32606.
- V MEMBERSHIP. None of the membership units of the professional limited liability company may be issued to anyone other than an individual licensed to provide professional dental services as a dentist or dental hygienist in the State of Florida.
