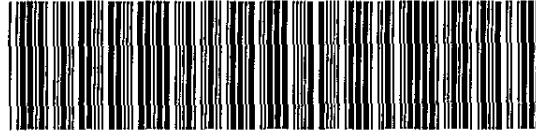

This limited liability company shall be perpetual in existence.


ARTICLE VI – SALE OF MEMBERSHIP UNITS


