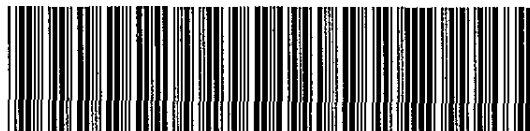


ARTICLE I: The name of the Limited Liability Company is: **Vitamundo, LLC**
