
ARTICLE VI - CONTINUATION OF BUSINESS

The Company shall be managed by its Members, subject to the terms of the Operating Agreement.

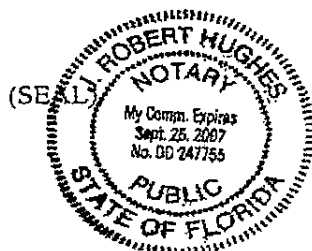

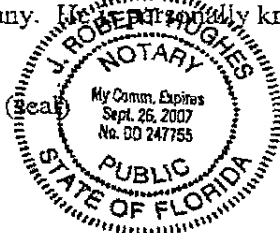


