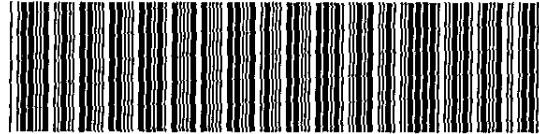

- SECOND:** The date of the adoption of these Articles of Dissolution is May 25, 2005.
- THIRD:** The dissolution of the Limited Liability Company was a unanimous agreement of all members.
