**ARTICLES OF ORGANIZATION
OF
INTEGRATED MEDICAL REHABILITATION OF FLORIDA, L.L.C.**

ARTICLE I - NAME

THE NAME OF THIS Limited Liability Company shall be INTEGRATED MEDICAL REHABILITATION OF FLORIDA, L.L.C.

ARTICLE II - ADDRESS

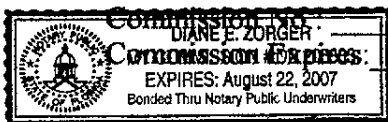

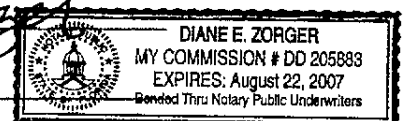
