ARTICLES OF ORGANIZATION

FOR

GOOD MORNING COFFEE, LLC

A Florida Limited Liability Company 816 Point Pleasant Place Altamonte Springs, Florida 32701

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I NAME

The name of this Limited Liability Company shall be GOOD MORNING COFFEE, LEC (hereinafter "L.L.C.").

ARTICLE II ADDRESS

The mailing address and street address of the principal office of the L.L.C. is 816 Point Pleasant Place, Altamonte Springs, Florida 32701.

ARTICLE III DURATION
