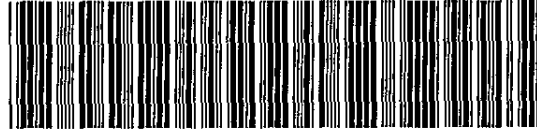

**ARTICLE V - LIMITATION ON AGENCY AUTHORITY OF MEMBERS**

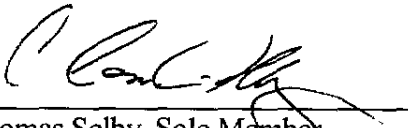

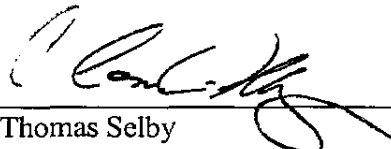
