# ARTICLES OF ORGANIZATION OF ROBERT GUETTLER SOD, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

### ARTICLE I-NAME

The name of the limited liability company shall be Robert Guettler Sod, L.L.C.
