ARTICLES OF ORGANIZATION OF BDG EAU GALLIE, LLC

- 1. NAME. The name of this limited liability company is BDG EAU GALLIE, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.
- 2. PLACE OF BUSINESS. The mailing address and street address of the Company's principal office is 6654 78th Avenue North, Piuellas Park, Florida 33781.
