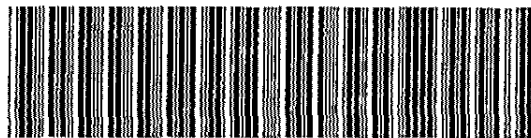



ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
OF
CHARLOTTE SELF STORAGE, LLC

THIS IS TO CERTIFY THAT:

FIRST: This Article amends the Articles of Organization of CHARLOTTE SELF STORAGE, LLC.

SECOND: The Articles of Organization were filed with the Florida Department of State on April 8, 2004 and assigned document number L04000029324.

THIRD: Article I of the Articles of Organization is hereby amended by deleting the existing Article I and replacing it with the following:

Article I

The name of the limited liability company shall be CHARLOTTE COMMERCE CENTER, LLC. The mailing address and the street address of the principal office shall be located at 150 Rio Villa Drive, Punta Gorda, Florida 33950, but it shall have the power and authority to establish branch offices at any other place or places as the members may designate.
