**ARTICLES OF ORGANIZATION  
OF  
MANGO PROPERTIES, L.L.C.**

**ARTICLE I**

**Name**

The name of the limited liability company ("Company") is MANGO PROPERTIES, L.L.C.

**ARTICLE II**

**Address**




