ARTICLES OF ORGANIZATION

OF

HARDWOOD UNLIMITED DESIGNS, L.L.C.

ARTICLE I - NAME

THE NAME OF THIS Limited Liability Company shall be **HARDWOOD UNLIMITED DESIGNS, L.L.C.**

ARTICLE II - ADDRESS

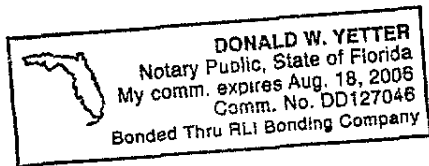
