Article VII - Limitation on Agency Authority of Members should be re-numbered as Article VIII - Limitation on Agency Authority of Members
Article VIII - Regulations should be re-numbered as Article IX - Regulations
- (2) A. The Second incorrect statement is an incorrect date located in the re-numbered Article V - Management. The incorrect statement is as follows:
